## I understand that if my Open Enrollment transfer application is approved for 2023-24:

- 1. Student must maintain attendance at 92% or greater; no more than one minor suspension per academic year; no suspension greater than five days and no expulsions.
- 2. Parent/guardian is responsible for providing transportation, which complies with school hours. Buses do not travel from the resident school to the open enrollment school; however, occasionally the student may live close to the attendance boundary of the open enrollment school. Parents should CALL to inquire about possible bus service.
- 3. Approval is for the duration of the students current school level only.
- 4. There is no guarantee of sibling applications being approved.
- 5. Commitment to attend any school should be for the entire academic year.
- 6. A lottery system may have to be implemented if there are more applications than allocations available.
- 7. Copies of the completed application will be distributed by the receiving school clerk, pending a letter or telephone conversation with the parent/guardian of the student, regarding the final recommendation.
